Notice Under Section- 28 Of U.P. Avas Evam Vikas Parishad Adhiniyam- 1965 (U.P.Act No. 1 of 1966)

The Uttar Pradesh Avas Evam Vikas Parishad has framed a scheme called "Jalaun Road Bhoomi Vikas Evam Grihsthan Yojana NO-1" Orai Jalaun. With a view to solve the Housing problem of Orai City. The boundary of the comprised area in the scheme are as follows:

North : Jalaun to Orai Road, Village, Pargana & Tehsil Orai District Jalaun.

East : Jalaun Bypass Road and Khasra No- 339 Part, 341 Part 335 Part 284, 288, 289 Village, Pargana & Tehsil Orai District Jalaun.

South : Khasra NO. 304, 306, 307, 308, 318, 315, 314, 313, Village, Pargana & Tehsil Orai District Jalaun. Boundary of Village Bohadpura, Pargana & Tehsil Orai District Jalaun. Khasra No. 272, 273, 274 (Chak Road) Village, Pargana & Tehsil Orai District Jalaun.

West : Khasra NO. 220(Canal)Village, Pargana & Tehsil Orai District Jalaun.

It is declared that when by the execution of the Housing and Improvement scheme aforesaid any land in the area comprised in the scheme which may not be required for the execution thereof, will in the opinion of the Board be increased in value, "Betterment fee" in accordance with the provisions of Uttar Pradesh Avas Evam Vikas Parishad Adhiniyam, 1965 shall be payable by the owner of the land or by every person having an interest there in respect of the increase in the value of the land resulting from the execution of the scheme.

Avas Evam Vikas Parishad, Collectorate Compound Mahoba within 30 days from the date on which notice is first published in Uttar Pradesh Gazette, Correct Name of the scheme, Name of objector full particular of the land/Building etc. Khasra No., area of land, name of the village, and other necessary details should be clearly mentioned in every objection.
