## Notice Under Section- 28 Of U.P. Avas Evam Vikas Parishad Adhiniyam- 1965 (U.P.Act No. 1 of 1966)

The Uttar Pradesh Avas Evam Vikas Parishad has framed a scheme called "Banda Road Bhoomi Vikas Evam Grihsthan Yojana NO-1" Mahoba. With a view to solve the Housing problem of Mahoba City. The boundary of the comprised area in the scheme are as follows:

**North :** Khasra No. 1130 Part, 1286, 1289, Part of Canal Village, Tehsil, District Mahoba.

**East :** Khasra No. 1290 Part, 1317, 1316, 1314, 1324, 1325, 1328, 1306, 1396 village, Tehsil, District Mahoba.

**South :** N.H. No-76 Mahoba, Banda, Kanpur Road Khasra No. 1394 village, Tehsil, District Mahoba.

**West :** Khasra No. 1376 (Canal), 1243, 1244, 1245, 1246, 1235, 1234, 1233, 1150, Village, Tehsil District Mahoba.

It is declared that when by the execution of the Housing and Development scheme aforesaid any land in the area comprised in the scheme which may not be required for the execution thereof, will in the opinion of the Board be increased in value, "Betterment fee" in accordance with the provisions of Uttar Pradesh Avas Evam Vikas Parishad Adhiniyam, 1965 shall be payable by the owner of the land or by every person having an interest there in respect of the increase in the value of the land resulting from the execution of the scheme.
