The Tender Documents (Two bids) shall be uploaded online in Two Parts:-

3.2 Part 1:- Shall contain ITB (Invitation to Bid) Conditions of Contract, Contract Data, scanned copies of all Technical Documents, Eligibility Information, Affidavit supporting correctness of informations furnished and documents supporting deposit of Earnest Money & Bid processing Fee, Drawings and Technical Specifications

Part 2:- Shall contain BOQ/Financial Bid.

3.2 The Tender Documents (Single bid) shall be uploaded online and contain BOQ/Financial Bid, Drawings and Technical Specifications. Condition of Contract, Contract Data, scanned copies of all Technical Documents/ Eligibility Information, Affidavit supporting correctness of information furnished and documents supporting deposit of Earnest Money Deposit / Bid Processing Fee.

4. **Submission of original Documents:** The bidders are required to submit original copies of documents supporting deposit of Earnest Money Deposit / Bid Processing Fee and Affidavit supporting correctness of information furnished and other Technical Documents in Office of the concerned Executive Engineer of U.P. Housing & Development Board, Mandola Vihar, Ghaziabad, as specified in Key dates Sl. No. 2(6) failing which the bids will be declared non-responsive. Bidders shall write only the bid-ID- number (generated through e-tendering website on submission of bid on-line) on the envelope containing the documents mentioned above and the package number for which they have bid. Bidders SHALL NOT WRITE their own names or name of their firm on this envelop in order to ensure confidentiality of the bid.

5. **Bid Opening Details:** The bids shall be opened on the date as mentioned in **Key dates** Sl. No. 2(5) **at 12:30 Hrs.** in the Office of the concerned Executive Engineer, Construction Division-22/38, U.P. Housing & Development Board, Mandola Vihar Yojna, Ghaziabad, by the authorized officer. In their interest the tendered are advised to be present at the time of opening of Tenders. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

6. The bid for the work shall remain valid for acceptance for a period not less than 90 days after the deadline date for bid submission.

7. Any bidder, who is having criminal record, is not allowed to participate in the bidding process.

8. Any bidder, who is registered with the State Bar Council, is not allowed to participate in the bidding process.

9. Bidders are advised to visit the site of the work before bidding.

10. Rates Mentioned in the Bill of Quantity of bids are inclusive of Royalty & other taxes but without Labour cess and GST.

11. Any corrigendum/addendum/modification in the bid document will be intimated through the website **www. etender.up.nic.in** only. Bidders are, therefore, requested to visit the website regularly to keep themselves update.

12. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidder's responsibility to verify the website for the latest information related to the tender.
