(NOTICE UNDER SECTION 28 OF THE U.P. AVAS EVAM VIKAS PARISHAD ADHINIYAM-1965, U.P. ACT. NO-1-1966)

South:- Khasra no. 23, 24, 25part & 27 Village- Sithauli Khurd, Pargana & Tahsil- Mohanlalgani District- Lucknow.

West:- Khasra No. 647, 646, 645 & 640part Village-Sithauli Kala, Pargana & Tahsil Mohanlalgani District-Lucknow.
