(Notice under section 28 of The Uttar Pradesh Awas Evam Vikas Parishad Adhiniyam, 1965 (Uttar Pradesh Act No. 1, 1966)

Avas Evam Vikas Parishad, House No. 85, First Floor, Brahmsthan, Azamgarh within 30 days from the first publication in Uttar Pradesh, Gazette of this notice. After passing of the due date, no objection shall be entertained.
